FILMRAW STANDARD LICENSE AGREEMENT

This Standard License Agreement ("Agreement") is made between FilmRAW ("Licensor") and the purchaser ("Licensee"). By purchasing, downloading, or using FilmRAW stock footage (the "Content"), the Licensee agrees to the terms and conditions outlined below.

1. Definitions

- 1.1 **Content** Digital video footage, images, and other media files made available by FilmRAW.
- 1.2 **Licensee** The individual or entity obtaining the license to use the Content.
- 1.3 **End Product** The final work incorporating the Content, distributed through permitted channels under this Agreement.

2. Grant of All Media License

However, this license excludes the following:

4. License Tiers

Standard License: Covers the above-permitted uses.

Premium License: Required for high-budget productions such as feature films,

national/international TV (excluding news), government use, corporate

advertising, and video games.

5. License Terms and Restrictions

5.1 Licensee **may not** resell, sublicense, or redistribute the Content as stock footage.

5.2 Licensee **may not** use the Content in a manner that is defamatory, pornographic, or violates any applicable laws.

6. Content Showing Depicted IP and Placeholders

Some Content may depict recognizable locations, trademarks, or products. FilmRAW **does not** provide model or property releases for such Content. Licensee assumes responsibility for obtaining any necessary clearances.

7. Credit Attribution

Credit is not required but is appreciated. If credited, please use: "Aerials by FilmRAW (filmraw.net)"

8. Representations, Warranties, and Disclaimers

8.1 FilmRAW does not warrant that the Content is free from third-party claims.

8.2 The Content is provided "as is", with no guarantee of suitability for a particular purpose.

9. Limitations of Liability

FilmRAW shall not be liable for indirect, incidental, or consequential damages arising from the use or inability to use the Content.

10. Term and Termination

This license is **perpetual** but may be revoked if the Licensee breaches any terms. Upon termination, Licensee must cease using the Content.
